History of Ballarat Bridge Club's Lease Agreement with City of Ballarat at 1001 Eyre Street Ballarat Ballarat Central

Compiled by Anne Beck from past Minutes of Meetings and other relevant documents on file

The Ballarat Bridge Club was established in 1985 as the Ballarat Bridge Club.

An agreement was made for between the responsible personnel of Ballarat Memorial Sports Inc. and Ballarat Bridge Club that the Ballarat Bridge Club sub-lease the the building from the Ballarat Memorial Sports (BMS), to take effect on May 01, 2005. (13 Clauses).

22nd August 2006. The Ballarat Memorial Sports Inc. put a proposal to the Ballarat Bridge Club for it to purchase the premises at 1001 Eyre Street \$115,000 with a \$15,000 payment on changeover and a further \$10,000 payment per year (\$5,000 June & December) for the next ten years.

Ballarat Bridge Club's Solicitor Morrow and Morrow and the Ballarat Memorial Sports Inc's Solicitor Heinz and Gordon each drew up contracts for the sale/purchase of the improvements and Ballarat Memorial Sports Inc.'s Lease from Ballarat Memorial Sports Inc. to Ballarat Bridge Club. It was noted that approval must be obtained from the Ballarat City Council to allow the sale and thus transfer of the lease from Ballarat Memorial Sports Inc. to Ballarat Bridge Club.

01st September 2006. A Report was made to Ballarat Bridge Club members about the proposed purchase.

11th September 2006. Extraordinary Meeting: The business being, 'The proposed purchase of the Eyre Street Premises.

02nd October 2006. At special General Meeting Ballarat Bridge Club passed the motion "that the Members of the Ballarat Bridge Club Inc. authorize Club to lease approximately +350 sqm of Crown Land on the SW corner of Eyre and Ripon Streets and purchase the existing club house building on this land.

30th October 2006. Committee to meet with Michael Morrow, Solicitor, to discuss various matters.

13th November 2006. Ballarat Bridge Club meeting with Ballarat City Council re lease of land

 14^{th} November 2006. Ballarat Memorial Sports Inc. and Ballarat Bridge Club meeting re Sale Agreement.

10th January 2007. Meeting with Michael Morrow, Solicitor re: Lease (only).

27th April 2007. Lease Agreement between between Ballarat City Council and Ballarat Bridge Club for 4 x 3 years commencing 10/12/2006 was signed.

Lease Agreement

• 2008-2012; 2012-2015; 2015-2018; 2018-2021 were the four, three year terms granted to the Ballarat Bridge Club in 2006. Further, the clause "the building and its entirety will remain the property of the Crown" is included in the Lease Agreement.

This Lease Agreement was signed by the relevant office bearers of the Ballarat Bridge Club.

- It is clear that the City of Ballarat is responsible for the upkeep and maintenance of the building. This includes the Insurance of the Building.
- The Ballarat Bridge Club is responsible for Contents Insurance and Public Liability Insurance which is available on application because of our Affiliated status with the Australian Bridge Federation (renewed in April)

Summary:

 At the time, Ballarat Bridge Club Inc. bought a building (that could not be sold) in good faith, for \$115,000; kept no record of statements of payment for the \$5,000 paid twice yearly (for auditing and financial reports).

- Although knowing otherwise from 2008, the relevant committees did not disclose to members that Ballarat Bridge Club did not own the building (contrary to common belief of members).
- Building Insurance was paid annually until 2019 (\$3,000 approx. for 10 years);
 Public Liability Insurance was paid annually until 2019 (\$1,000 approx. for 10 years).
